# ELECTION NOTICE - E2020/113

---

### Scheduled Election

*Fair Work (Registered Organisations) Act 2009*

Nominations are called for:

- National President (1)
- National Senior Vice President (1)
- National Secretary (1)
- National Treasurer (1)
- Vice Presidents (3)\*

*\*Rule 18.3.1 provides that the number of Vice President positions on the National Board shall be three, provided that where a woman has nominated for the National Board but no woman has been elected to the National Board, a fourth Vice President's position shall be created by the Returning Officer to be filled by a woman.*

**Nominations**, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 19/02/2021. Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method stipulated below **not later than** 12:00pm Australian Eastern Daylight Time (AEDT) **on** 05/03/2021.

A nomination not accompanied by a statement and photograph shall be deemed to be defective.

**How to lodge nominations**, nominations must be lodged via the following method(s):

**By Email:** A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to [IEBnominations@aec.gov.au](mailto:IEBnominations@aec.gov.au).

**PLEASE NOTE:**

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 03 9285 7129 to enquire about the status of your nomination.

### Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm Australian Eastern Daylight Time (AEDT) on 05/03/2021.

### Candidate Statements and Photo

Each nomination form **must** be accompanied by a written election statement and photo (resolution size must be suitable for reproduction) of the nominee.

The statement must be related to the nominee and the position for which nomination is made. The statement must be more than 200 words but not more than 500 words in length,

A nomination not accompanied by such statement and photograph shall be deemed to be defective.

### Voting Period

The ballot, if required, will open on 26/03/2021 and close at 10:00am Australian Eastern Standard Time (AEST) on 23/04/2021.

### Scrutineers

The appointment of scrutineers opens 19/02/2021 and closes 12:00pm Australian Eastern Standard Time (AEST) on 22/04/2021.
